Family Computer Use Policy

I agree that computers can give me the power to access a great deal of information very quickly. I also understand that the Internet has no real rules in place to protect young people like myself. It is with this in mind that I agree to obey the following rules for my own protection while using the computer:

1. I shall use the computer in a visible place where my parents may watch what I do. They are not watching to be nosy, only to be careful about what I am doing on the Internet or in chats. I also give them permission to view my e-mails and chats (both incoming and outgoing).
2. I may not use the computer at all times. There are certain times of day when my family is present in the house and able to assist me in the event I need to ask whether I may visit a site on the Internet. I also agree that I may need to limit the amount of time that I spend in front of the computer.
3. If someone, in a chat or e-mail, writes, sends a picture, or something that makes me feel uncomfortable or scared, I understand that it is NOT my fault and shall report the incident to my parents who may then take the necessary steps to help protect me.
4. I understand that even if I become friendly with someone over the Internet, the "new" friend that I have made is still a STRANGER. I will only use a made up name when online and recognize the fact that there are both good and bad people that may say that they are my "friend" online.
5. I will NEVER use bad or mean language or any language to make other people scared or uncomfortable, nor will I send "dirty" pictures to others. I understand that I must do my part to make the World a better place to live and that by being courteous, I can help to make a good start.
6. I shall not give out personal or private information, including my address, phone number, social security number, birthday, or school to anyone nor will I send pictures of myself or my family over the Internet without my parents giving me direct permission to do so.
7. If someone asks me over the Internet to meet with them, I shall NEVER do so until I have discussed it with my parents AND they have given me permission to do so.
8. I shall request permission from my parents BEFORE I download/install any games or programs onto the computer.
9. I understand that not all places on the Internet are suitable for my viewing, whether it is because of the subject or content of the website. I shall discuss and agree to the types of websites that I am allowed to visit BEFORE I go online and go ONLY to those sites.
10. I will NEVER give out my passwords to anyone—not even to my friends, whether online, in e-mails, in chats, or in person. Even if I get an "official" message from somewhere telling me to do so, I understand that no one is allowed to request it, so I shall not give it to them.

I understand, that if I fail to follow the rules listed above, that my privilege of using the computer for accessing e-mail/Internet/chat may be taken away for as long as my parents feel is necessary.
